Patient Services A childhood cancer diagnosis is a frightening, stressful, and confusing time Even the strongest family foundations are challenged Less secure foundations can sometimes be shattered ACCOIN addresses the social, psychological, and financial needs of children with cancer and their families by providing hands-on direct support through educational materials, support groups, stress reducing activities, practical supplies to assist with hospital life, and financial assistance During fiscal year 2011/2012, ACCOIN served 55 newly diagnosed children with cancer or with relapsed disease, approximately 200 families currently in treatment or on follow-up care, and an overall membership that includes 375 families currently in-treatment, long-term survivors, or bereaved families With an office located at Sacred Heart Children's Hospital in Spokane, WA, ACCOIN provides a safe haven for parents and children to find respite during treatment
