For instance we had a cultural and language program and we needed some work completed on a grant. The work required the contractor to have the academic credentials, research experience, orthography, and fluency in the Sug'stun language. The only person in the entire State that had the credentials and skills was the brother of the Program Manager. Chugachmut would not contract where there was a conflict of interest, for instance Chugachmut would not use an employee from Mutual of America to do our audit prep for the retirement plans, because Mutual of America is the plan custodian. Chugachmut also ensures employees are not performing outside work that may be a conflict of interest with Chugachmut. Employees must submit for approval by the Executive Director the name of the organization and scope of work which the Executive Director reviews prior to approval. Services provided through grants are mostly income driven and have strict parameters and are audited annually.
