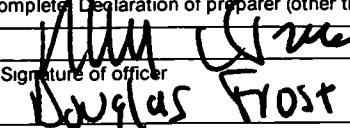
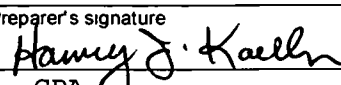

The college's financial departments select the initial qualifying students who are then interviewed by the Kiwanis Club Foundation committee members for final selection.

The Foundation supported the local youth of the community by supporting public school counseling and guidance departments and by supporting the youth Kiwanis Clubs (Builders and Key Clubs). The Foundation supported Children's Hospital, Ronald McDonald House, Burn camp, Food Bank and other youth service organizations.

The Foundation gave to other non-affiliated charities such as environmental and conservation charities such as San Diego Riverpark Foundation & Ecolife, and international charities such as International Relief Team.
