Dr. Samuel Hellman, the former Dean of the University of Chicago Medical School, was both a Trustee of the organization and a member of the Institute's Board, serving as Chairperson of its Executive Committee and as a member of its Compensation Committee. In addition, the four voting Trustees serving on the Board of the Institute also constituted the majority of the Institute's Executive Committee and of the Institute's Compensation Committee during the tax year.
