Humanities to Go brings neighbors together for learning and thoughtful conversation while connecting NH residents to our states rich historical and cultural resources. The Humanities to Go speakers bureau includes 200 different high-quality lectures and living history presentations by 100 different NH scholars. This deceptively simple program offers a lifeline to cash-strapped local organizations that could not afford to create or pay for such programs on their own. In 2015, Humanities to Go partnered with 275 local host organizations in 162 NH communities to sponsor 448 programs attended by more than 14,457 people.

New Hampshire Humanities celebrated its 40th anniversary with 40 signature events held throughout the state. We honored 40 humanities heroes 40 over 40 recognized author Tomie DePaolas contributions to childrens literature at a Connections Literacy celebration examined contemporary issues such as The American Dream Myth or Reality and Privacy in the Age of Big Data at three Ideas on Tap pub-based discussions offered Humanities in Action through a contradance, mountain hike and nature walk that combined physical activity with reflection challenged 200 NH high school students to consider the role of money in a democracy in a Constitutionally Speaking student conference, premiere Who Am I Going To Be, a documentary on the stones of four African refugee teens rebuilding their lives in NH and booked the year with Annual Dinners featuring Pulitzer Prize-winning novelist Michael Chabon and bestselling nonfiction author and human rights activist Azar Nafisi. In all, 51,721 NH residents participated in 40th anniversary events over the course of the year.

Community Project Grants enable New Hampshire Humanities to be responsive to the needs and interests of NH residents. Grant-funded projects in FY15 included an examination of end-of-life issues through a textile exhibit and lecture-discussion series in Wolfeboro, a teacher workshop in Keene on the Industrial Revolution, an oral history workshop in Plainfield, and a community book discussion series on the contemporary relevance of the Grapes of Wrath. In FY15, the New Hampshire Humanities Board of Directors, through its Program Committee, approved 15 competitive grants totaling 48,805 matched by approximately 147,744 in community support.
