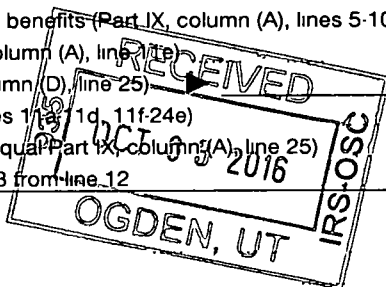

FOR THE FOUNDATION'S FISCAL YEAR ENDING 10/31/2015, THE TRUSTEES RECEIVED 109 APPLICATIONS AND MADE 34 AWARDS TOTALING \$193,637.00. ACCORDING TO MR. WHITING'S WILL, THE BENEFITS UNDER THE FOUNDATION ARE TO BE CONFERRED AT THE SOLE DISCRETION OF THE TRUSTEES BUT SHALL NOT AT ANY TIME BE DENIED FOR REASONS OF RACE, COLOR, NATIONALITY, RELIGION OR GENDER.
