THE RHODE ISLAND COUNCIL FOR THE HUMANITIES (THE COUNCIL) MARKED SEVERAL SIGNIFICANT ACCOMPLISHMENTS DURING THE 2015 FISCAL YEAR, THE FIRST YEAR OF THE COUNCIL'S FIVE-YEAR STRATEGIC PLAN, CATALYZING THE HUMANITIES. THE COUNCIL CONTINUED ITS ROBUST GRANTMAKING PROGRAM, AWARDING \$172,827 TO 37 GRANT PROJECTS IN SUPPORT OF PUBLIC HISTORY, CULTURAL HERITAGE, CIVIC EDUCATION, AND COMMUNITY ENGAGEMENT ACROSS THE STATE. OVERALL, THESE INVESTMENTS LEVERAGED MORE THAN \$553,000 IN ADDITIONAL SOURCES OF FUNDING FOR THE COUNCIL'S GRANTEE DR WILLIAM ADAMS, THE CHAIRMAN OF THE NATIONAL ENDOWMENT FOR THE HUMANITIES, JOINED U S SENATOR JACK REED AND STAFF AND BOARD MEMBERS FROM THE COUNCIL TO ANNOUNCE GRANT AWARDS AT A PUBLIC EVENT HELD AT THE PROVIDENCE PUBLIC LIBRARY. THE COUNCIL COMPLETED THE SECOND YEAR OF CATALYZING NEWPORT, AN INITIATIVE SUPPORTED BY THE VAN BEUREN CHARITABLE FOUNDATION TO CONVENE LOCAL ORGANIZATIONS AND CITIZENS AND CREATE A NEW VISION FOR A RESILIENT, SUSTAINABLE, AND INNOVATIVE CITY. THE COUNCIL HOSTED FOUR SUCCESSFUL RESIDENCIES BY NATIONAL THOUGHT LEADERS IN THE AREAS OF PLACEMAKING, CULTURAL POLICY AND RESEARCH, SYSTEMS LEADERSHIP, AND DIGITAL HUMANITIES, AND MOBILIZED CROSS-SECTOR, LOCAL ACTION TEAMS OF GOVERNMENT OFFICIALS, POLICYMAKERS, AND CULTURAL AND COMMUNITY LEADERS TO ADDRESS CHALLENGES IN NEWPORT'S CULTURE, CIVIC LIFE, AND ECONOMIC OPPORTUNITIES. THE COUNCIL ALSO LAUNCHED THE PELL HUMANITIES INITIATIVE IN PARTNERSHIP WITH THE PELL CENTER FOR INTERNATIONAL RELATIONS AND PUBLIC POLICY AT SALVE REGINA UNIVERSITY AND THE UNIVERSITY OF RHODE ISLAND LIBRARIES TO CELEBRATE THE 50TH ANNIVERSARY OF THE NATIONAL ENDOWMENT FOR THE HUMANITIES AND TO HONOR THE LEGACY OF RHODE ISLAND'S LATE SENATOR CLAIBORNE PELL. THE INITIATIVE CONNECTS ACADEMIC INSTITUTIONS AND HUMANITIES ORGANIZATIONS ACROSS THE STATE AND ACTIVATES THE ROBUST NETWORK OF HUMANITIES PROGRAMMING IN RHODE ISLAND. THE COUNCIL RECOGNIZED FOUR HONOREES FOR THEIR OUTSTANDING CONTRIBUTIONS TO THE HUMANITIES IN RHODE ISLAND AT THE 2015 CELEBRATION OF THE HUMANITIES, HELD AT THE CENTER BY THE BLACKSTONE IN PAWTUCKET. OVER 300 COMMUNITY MEMBERS, BOARD DIRECTORS AND ALUMNI, GRANTEE, GOVERNMENT LEADERS AND LEADERS OF ARTS AND CULTURAL INSTITUTIONS GATHERED TO CELEBRATE THE ACHIEVEMENTS OF THE HUMANITIES IN RHODE ISLAND. THE RHODE ISLAND CENTER FOR THE BOOK'S 2015 READING ACROSS RHODE ISLAND PROGRAM SELECTION, NORWEGIAN BY NIGHT BY DEREK MILLER, CONNECTED THOUSANDS OF RHODE ISLAND READERS THROUGH INTERGENERATIONAL PROGRAMMING AT SCHOOLS, LIBRARIES, BUSINESSES, BOOKSTORES, AND SENIOR CENTERS. WITH SUPPORT FROM THE TD BANK CHARITABLE FOUNDATION, THE KIDS READING ACROSS RHODE ISLAND PROGRAM GREW CONNECTIONS BETWEEN SCHOOL AND SUMMER READING FOR KIDS IN GRADES 3-6 BY HOSTING FREE LIBRARY PROGRAMS IN DIVERSE COMMUNITIES AND DISTRIBUTING OVER 1750 COPIES OF THE 2015 SELECTION, FLORA & ULYSSES BY NATIONAL AMBASSADOR FOR YOUTH LITERATURE KATE DICAMILLO. THE CENTER FOR THE BOOK ALSO ENGAGED OVER 700 RHODE ISLAND STUDENTS IN GRADES 4-10 IN THE LETTERS ABOUT LITERATURE READING PROMOTION PROGRAM.
