The Association has no amounts accrued for interest or penalties as of October 31, 2015 and 2014. The Association is no longer subject to examination by U.S. federal or state taxing authorities for years before 2012. The Association does not expect the total amount of unrecognized tax benefits to significantly change in the next 12 months.
