CASH GRANTS WERE PRIMARILY FOR THE NEW WEST END MARKET AND HISTORY & HERITAGE CENTER. FUNDS ALSO SUPPORTED PERFORMING ARTS THROUGH ARTS A'FAIR, VOCABULARY-BUILDING THROUGH ALPHABET FOREST, PUBLIC ART EXPERIENCE THROUGH GIANT SING-ALONG, MATH LITERACY THROUGH MATH ON-A-STICK, AND PROJECTS THAT IMPROVED THE FAIRGROUNDS WITH SEATING AND TREES. FOUNDATION SUPPORT IS ALIGNED WITH THESE STATE FAIR PROGRAM AREAS: AGRICULTURE, ART, FAIRGROUNDS ENVIRONMENT, HISTORY AND HERITAGE, AND EDUCATION. THE FOUNDATION ALSO RETAINED ASSETS FOR FUTURE GRANTS, AND CONTINUED TO BUILD ENDOWMENT FUNDS. THE FOUNDATION'S OPERATING EXPENSES ARE FUNDED THROUGH CONTRIBUTIONS, EARNED INCOME, AND SUPPORT FROM THE STATE FAIR. THE FOUNDATION IS LED BY A 20-MEMBER BOARD OF DIRECTORS.
