**SAPLINGS PROGRAM:** This program includes initiatives for rescuing saplings not designated for treatment, potting and maintaining them in a nursery setting, offering them to the public for adoption, hemlock restoration on trout streams, creation or augmentation of hemlock field insectaries for raising predator beetles, and donation of saplings to other nonprofits. In 2016 we conducted 13 rescue projects for 202 saplings & 245 seedlings, 1 hemlock restoration project planting 60 saplings, 1 field insectary project planting 24 saplings, 3 other planting projects for 14 saplings, adopted 179 saplings out, and donated 37 large saplings & 230 seedlings to schools and other nonprofits.
