During that year contributions and registrations were paid to and directly collected by HITWG, which received \$489,283.

No grants were made by Angel Charities during its initial fiscal year ended November 30, 2015. Angel Charities expects to begin its grantmaking in the fiscal year ending November 30, 2016.
