4a (Code:) (Expenses \$ 123,111 including grants of \$ 250) (Revenue \$ 110,057)
South Park baseball continued to flourish in FY 2014. We had approximately 500 boys & girls participate during our Spring and Fall leagues, which encompassed t-ball (ages 4 & 5), rookie coach pitch (ages 5 & 6), coach pitch (ages 7 & 8), minors (ages 9 & 10), majors (ages 11 & 12) and Babe Ruth (ages 13 & 14). In addition to the revenues noted above, baseball received approximately \$29,000 of contributions from companies & individuals to help finance our program. All baseball coaches are volunteer parents who receive no compensation for their efforts. SPYA policy mandates that all coaches pass a background check on an annual basis in order to coach. Baseball teams are selected (drafted) each season subsequent to all players attending a skills day assessment, which helps ensure that our teams are as even as possible and creates fair competition. Some participants received partial or full financial aid to cover registration fees.

4b (Code:) (Expenses \$ 86,788 including grants of \$ 0) (Revenue \$ 82,391)
South Park lacrosse continued to flourish in FY 2015, with approximately 325 boys and girls participating in the program. In addition to the revenues noted above, lacrosse received approximately \$12,000 of contributions from companies and individuals to help finance our program. The lacrosse program expanded into a couple of more middle schools within the Charlotte Mecklenburg school system this past year, bringing the total middle schools programs under our league to six. Coaches for SPYA lacrosse teams include volunteer parents as well as individuals with college / pro lacrosse experience who receive a nominal amount of pay for their coaching activities. SPYA policy mandates that all coaches pass an annual background check in order to coach. SPYA is now one of the three largest youth lacrosse programs in the Charlotte NC area. Some participants received partial or full financial aid to cover registration fees.

4c (Code:) (Expenses \$ 65,134 including grants of \$ 0) (Revenue \$ 59,022)
In FY 2014, South Park football once again fielded 7 teams. This was the first year in the last several years where we did not see a decrease in the number of participants, which held steady at approximately 185 players. Our football league was once again aligned with Pop Warner youth football, which requires kids to participate based on age and weight restrictions to help ensure their safety. All coaches are now required to complete an annual course on "heads up" football in order to ensure they are teaching proper techniques to the players. In addition, all football coaches are volunteer parents who receive no compensation for their efforts. SPYA policy mandates that all coaches pass an annual background check in order to be eligible to coach. Some participants received partial or full financial aid to cover registration fees.
