The program weatherized 235 units and through programs in conjunction with utility companies provided 5,841 households with energy assistance in 2015. Coordination of all services provided resources to move 43 individuals successfully out of poverty.

Education-Services provided through Head Start program for childcare, education and support services for children ages 0 to 5. The program assists in the total development of the child through health, nutrition, education and parent involvement.
