AN ESTIMATED 2.5 MILLION CUBIC FEET OF MATERIAL WAS COLLECTED FROM THE LOCAL COMMUNITY AND DIVERTED FROM THE LOCAL LANDFILL. OVER 3,500 EDUCATORS AND 135,000 STUDENTS USED THESE MATERIALS FOR EDUCATIONAL PURPOSES. MATERIALS ARE SOLD AT A NOMINAL COST OR PROVIDED FREE TO THE TEACHERS THROUGH OUR WAREHOUSE WHICH IS OPEN 35 HOURS PER WEEK. A TOTAL OF 700 VOLUNTEERS WORKED 12,400 HOURS IN PROVIDING SERVICES TO OUR MEMBERS. THE EXPENSES FOR OUR SERVICES REFLECT PAYROLL, TRUCK EXPENSES (GAS & INSURANCE) AND FACILITY EXPENSES. IN ADDITION, TREASURES 4 TEACHERS PARTICIPATES IN THE KIDS IN NEED FOUNDATION'S SCHOOL SUPPLY DISTRIBUTION PROGRAM. DURING 2015, TREASURES 4 TEACHERS RECEIVED SCHOOL SUPPLIES VALUED AT MORE THAN \$2 MILLION FROM KIDS IN NEED FOUNDATION TO BE DISTRIBUTED AT NO CHARGE TO MEMBERS FOR USE IN LOCAL SCHOOLS.
