We continue to expand our physician specialty practice - with new services in pain management. With a commitment to the highest quality surgical care - AVH is leading the way to a healthier future for our health care community.

Educational programs offered by AVH include childbirth classes, babysitting course, wellness fairs, lecture series, CPR and first aid courses, nutritional counseling, and a variety of support groups.
