LAND PROTECTION 2015 saw continued success in our land conservation work, with more than 730 acres permanently protected by SELT through 8 new projects. Many of these projects expanded the Pawtuckaway to Great Bay Greenway with new SELT ownerships. These include the donated 109 acre Burley Forest in Epping, the 238 acre Burley Farms and 84 acre Haley Woods (sold to SELT at a generous bargain price), and the 200 acre Bald Hill Forest on and near the Lamprey River in Epping, Newmarket, and Newfields. SELT also accepted generous gifts of the 7 acre Powwow River Woodlands in South Hampton and the 34 acre Victor Garrison Memorial Forest in Brentwood and Fremont, adjacent to the existing Kelliher Memorial Forest. Easement projects completed included a conservation easement on the Short property in Stratham, providing a critical link for expansive trails at Stratham Hill Park. CONTINUED ON SCHEDULE O

EASEMENT STEWARDSHIP Each year, including 2015, SELT monitors 100% of the 168 conservation easements we hold to ensure continued protection of the natural resources we've worked over many years to conserve. To address the additional easements received from the 2014 merger with the Straford Rivers Conservancy, SELT hired a full time Conservation Easement Monitor and continued our effective Volunteer Easement Monitor Program. Volunteers monitored 26 properties in 2015 with extensive property visits and evaluations. We also continued to work with our partners to ensure the monitoring of the 44 easements which we hold the executory interest on (back up to the primary easement holder). SELT remains committed to handle all trespasses or violations, no matter how small or large, in an amicable way to ensure a successful resolution where a positive relationship remains between us, the landowners and neighbors. We also continue to build on the relationship we have with the landowners of conservation easements, not just through our annual monitoring. CONTINUED ON SCHEDULE O

LAND MANAGEMENT In 2015, SELT added seven new ownerships, growing our owned lands to 34 reservations encompassing approximately 3,624 acres. Dedicated volunteers were critical to help maintain and improve SELT lands for recreation, animal and plant habitat, water quality, and more. Project work included habitat improvement and timber harvesting at the Kelliher and Victor Garrison Memorial Forests, habitat and restoration work at Mast Head Road Natural Area including a turtle nesting site, repairing deeply rutted trails from off-highway recreational vehicles (OHRV) to restore wetland habitat, trail and bridge completion at the Pawtuckaway River Reservation in Raymond, and completion of the trails, kiosks, and associated trail guide and map for the Tucker & French Family Forest in Kingston.
