NH Peace Action Education Fund's top three program accomplishments in 2015 as measured by expenses incurred would be, issue education, bringing the struggle for peace forward in the public dialogue by leveraging the media focus on New Hampshire created through the NH presidential primaries, and youth empowerment. While outcomes are difficult to assess, several national media stories were based on the work of our members and staff who engaged in the public forums created through the NH primaries by asking difficult questions to the candidates, holding signs and banners, and talking to media about issues of war and peace. Over 30 public education events were held, including speakers, conferences, and film showings, which attracted between 20 and 120 people to each event. A small group high school students attended our youth overnight and engaged in meetings to plan action around issues of peace and justice, receiving campaign training and support of from NH Peace Action, about twenty high-school aged youth engaged in NH Peace Action Education Fund's youth program in 2015.
