Life in Abundance (LIA) mobilizes the local church to facilitate transformational development among the poor and the vulnerable LIA trains and equips local churches, strategically located in hurting communities, so they can meet their communities pressing needs This is done by equipping and coming alongside local churches to address root causes of poverty through integrated programs with sustainable impact The community-based projects include orphans and vulnerable children programs, early childhood education programs, primary health initiatives such as church-based clinics, HIV/AIDS home based care and prevention, water and sanitation programs, skills development initiatives, Training & leadership development as well as economic empowerment projects In 2015 LIA partnered with a total of 315 churches for transformational development programs of which 59 were new partner churches in 10 African countries and 2 Caribbean countries A total of over 65,000 people were served, of which 11,201 were served in the Orphans and vulnerable children programs as well as Early Childhood development 43,923 were served through our Community health initiatives Of importance 1,350 community resource persons were trained in the various communities we serve Through our economic empowerment programs, 1,350 poor and vulnerable people were trained and engaged in income generating initiatives LIA expanded into two new countries Rwanda and DR Congo We also saw the completion of the first two phases of a training center in Nairobi and the graduation of the first three classes from this facility LIA also hosted for the third time, the annual global missions health conference in Nairobi, this time including a preconference training for doctors as well as a post conference for church and development workers This conference has now gained accreditation by the medical board to provide continuing education credits
