

The Rachel Corrie Foundation for Peace and Justice holds public forums, lectures, and conferences from time to time and also periodically attends the functions of other groups to educate the public on peace and justice issues. At these events, the foundation often has a table with brochures and other literature about the foundation and about various peace and justice issues. In addition, to educate the public about the economy of the Middle East and to attract people to our table for the free information, at these tables we often sell olive oil, art, and embroidery made small farmers and individuals in the Middle East and sold on a fair trade basis. We also carry several books related to and justice issues, the most expensive of which is about \$14. We do ask that the public pay for these more expensive items, as the foundation does not have the resources to give them away. Most sales are made away from the foundation's office by unpaid volunteers. While the gross profit from this activity (\$6,601) is above \$1,000, the activity is exempt from tax both because it is related to the foundation's exempt purpose and because the sales are substantially by unpaid volunteers. "An unrelated trade or business does not include a trade or 1. In which substantially all the work is done for the organization without compensation..."
