MINUTES OF THE 2015 ANNUAL MEETING OF THE BAGAN FOUNDATION

Saturday, December 26, 2015, at 173 School Street, Concord, New Hampshire 03301

Present: Trustees Merwyn Bagan, President and Treasurer; Karin A. Bagan, Vice President; Carol J. Bagan, Secretary. Trustee Seth Bagan was unable to attend and was consulted by email. The agenda and proposed business of the meeting was distributed by email and post two weeks in advance for review and comment and accepted as proposed. The Annual Meeting confirmed the consensus.

President Merwyn Bagan called the meeting to order at 3pm.

Order of Business:

- 1) The Minutes of the 2014 meeting were reviewed and approved.
- 2) The Financial Report of the Foundation was reviewed. The Foundation's assets are doing well under the Financial Manager, John Conway of UBS in New York City. The Foundation was formed in 1999 with \$300,000, has distributed \$316,201 to date, and has over \$400,000 in principal assets now. The Trustees will continue to self-file the Foundation's tax returns and New Hampshire reporting.
- 3) The 2014 grants were reviewed and the final report showed that all grantees had satisfied the terms of acceptance. The revised application deadline of October 15 enables further examination of requests and better informed decision-making prior to the distribution of grants.
- 4) The 2015 Grant Request file was carefully reviewed, with consideration given to each of the 24 applicants. Each application was weighed against the mission statement and attention was focused on Concord, New Hampshire, concerns. With assets of \$452,622.00 at December 31, 2014, the Foundation must distribute a minimum of \$22,631.00. After considering the needs reflected in the proposals, the Trustees voted to increase the funding and grant a total of \$39,150.00 as follows:

\$25,000 – Abbot-Downing Historical Society, for purchase of historic Concord vehicles
\$ 3,000 – Concord Community Concert Association, for general support
\$ 2,500 -- Catch Neighborhood Housing, first payment toward \$10k challenge in 3 years
\$ 1,000 -- Boys & Girls Clubs of Central New Hampshire, to support the art department
\$ 1,000 – Concord Public Library Foundation, for Children's Room Multi-cultural collection
\$ 1,000 – The Friendly Kitchen, for general support of the mission
\$ 1,000 -- The Leopold Schepp Foundation, for support of scholars and fellowships
\$ 1,000 – NH Community Loan Fund, for general support of the mission
\$ 1,000 – Symphony NH, for support of concerts in Concord
\$ 500 – Centennial Senior Center, for support of GoodLife Activities and Programs
\$ 500 – ConcordTV, for Concord On Air project
\$ 500 – New Hampshire Humanities Council, for general support
\$ 500 – New Hampshire Preservation Alliance, for general support
\$ 500 -- The Hundred Club of New Hampshire, for general support of its mission
\$ 150 -- The Friends of The Concord City Auditorium, for support of historical DVD
