THE HOUSING REHABILITATION PROGRAM. THE REHAB PROGRAM CONSISTS OF CONSTRUCTION MANAGERS THAT OVERSEE A REHAB PROJECT FOR LOW INCOME HOMEOWNERS THAT ARE RECEIVING A LOAN FROM NWWVT. AS THE LOAN PROCESS PROCEEDS, CONSTRUCTION MANAGERS ARE COMPLETING A SCOPE OF WORK AND GETTING BIDS FOR THE PROJECT. ONCE THE LOAN IS APPROVED, THE MANAGEMENT CONTINUES WITH OVERSIGHT AND AN ESCROW PAYMENT. THE PROJECT CONCLUDES WHEN ALL REHAB WORK IS COMPLETE TO THE SATISFACTION OF THE HOMEOWNER. THERE ARE APPROXIMATELY 50 HEALTH AND SAFETY REHAB PROJECTS COMPLETED EACH YEAR. THE BETTER BUILDING PROGRAM, AS PART OF THE HOUSING REHABILITATION PROGRAM, WAS DEVELOPED TO IMPROVE THE EFFICIENCY OF HOMES IN RUTLAND COUNTY. THE GOAL WAS TO HAVE HOMEOWNERS SAVE SIGNIFICANT MONEY ON HEATING COSTS-AN AVERAGE OF 375 GALLONS OF HEATING FUEL SAVED ANNUALLY. SINCE THE INCEPTION OF THE PROGRAM, HOUSING STOCK IN RUTLAND COUNTY HAS IMPROVED, LOCAL JOBS HAVE BEEN CREATED, AND SIGNIFICANTLY LESS CARBON DIOXIDE ENTERS THE ATMOSPHERE.

HOMEOWNERSHIP PROGRAM. THE HOMEOWNERSHIP PROGRAM CONSISTS OF BOTH EDUCATION AND COUNSELING FOR SUSTAINABLE HOMEOWNERSHIP. EDUCATION IS OFFERED FOR FINANCIAL LITERACY AND PRE-PURCHASE HOMEOWNERSHIP. COUNSELING IS OFFERED FOR PRE-PURCHASE, FORECLOSURE AND DELINQUENCY AS WELL AS REVERSE MORTGAGE. THERE ARE APPROXIMATELY 150 PARTICIPANTS EACH YEAR ATTENDING HOMEOWNERSHIP AND FINANCIAL LITERACY EDUCATION CLASSES AND APPROXIMATELY 350 THAT TAKE ADVANTAGE OF SOME COUNSELING SERVICES OFFERED.

REAL ESTATE ACTIVITIES. NWWVT PARTICIPATES IN THE NEIGHBORHOOD STABILIZATION PROGRAM THAT IS ADMINISTERED BY VERMONT HOUSING AND FINANCE AGENCY AND A NEIGHBORHOOD REVITALIZATION PROJECT ADMINISTERED BY VERMONT COMMUNITY DEVELOPMENT PROGRAM (VCDP). VHFA PURCHASES A FORECLOSED PROPERTY AND HANDS IT OVER TO NWWVT FOR COMPLETE REHAB AND ENERGY EFFICIENCY WHERE NWWVT BUYS THE HOME IN THE VCDP PROJECT. ONCE THE REHAB PROJECT IS COMPLETE, NWWVT FINDS AN INCOME QUALIFIED HOMEOWNER TO PURCHASE THE HOME WITH GRANT SUBSIDIES. ONCE THE HOME IS PURCHASED, IT REMAINS PERPETUALLY AFFORDABLE AS THE ORIGINAL GRANT SUBSIDIES REMAIN WITH THE HOME THROUGH SHARED EQUITY COVENANTS. NWWVT HAS COMPLETED APPROXIMATELY 5 HOMES EACH YEAR. THE PROGRAM HAS RUN. IN ADDITION, THERE WERE 2 REAL ESTATE DEVELOPMENT PROJECTS ACTIVE IN 2015. IN TOTAL, THERE ARE 3 REMAINING BUILDING SITES READY FOR NEW HOMEOWNERS AND 1 COMPLETED HOME FOR SALE AT THE END OF 2015.
