| <p>Quality Improvement &amp; Education NICQ Next continues the series of intensive improvement collaboratives sponsored by Vermont Oxford Network. Interdisciplinary teams from 61 institutions in North America are working together to improve the quality and safety of medical care for newborn infants and their families by integrating the concepts of family-centered care, the context for improvement, increased value, and standardization into their collaborative improvement work, addressing Care of the Micropremature Infant, Minimizing Brain Injury, Minimizing Lung Injury, Optimizing Nutrition, and Minimizing Iatrogenic Harm - Patient Safety is Job #1. This two year project commenced in January 2014 and concluded in December 2015. iNICQ Web Conference Series - In 2015, the Vermont Oxford Network iNICQ series continued its focus on Neonatal Abstinence Syndrome with an internet-based quality improvement collaborative designed to assist teams of obstetric and neonatal professionals to improve the quality, safety, and efficiency of care for substance-exposed newborns and their families. iNICQ centers and statewide collaboratives focused on adopting a standardized universal interdisciplinary training curriculum which included content from 35 of the leading experts in NSA care, including the author of the AAP Guidelines, Dr. Mark Hudak. Beginning in May 2015, the iNICQ Collaborative used online technology to enhance their work on NSA. Over 8,000 enrolled learners were supported by the Learning Management System as they completed 17 NAS micro-lessons. Once 85% of the enrolled team members completed this critical training, their center was designated as a "Vermont Oxford Network Center of Excellence in Education and Training for Infants and Families Impacted by Neonatal Abstinence Syndrome." In 2015, the iNICQ Alarm Safety collaborative assisted centers and newborn care units to improve the quality, safety, and value of clinical care by ensuring safe use and monitoring of oxygen therapy to minimize key morbidities such as BPD and ROP. This collaborative will also assist centers in meeting The Joint Commission-mandated National Patient Safety Goals, (NPSG 06.01.01) focused on alarm safety. A total of 108 centers from 33 states, United Arab Emirates, and United Kingdom participated in the team-based curriculum in an effort to make measurable improvements in quality and safety, learn about the evidence, about improvement, and engage families as partners in improvement. Annual Quality Congress: The 2015 Vermont Oxford Network Annual Quality Congress was held on October 3 and 4, 2015 in Chicago, IL. The aim of the AQC 2015 meeting was to bring together parents, leading academic neonatologists, scientists and practicing clinicians in neonatal medicine to discuss and determine the current status of knowledge and evidence-based content addressing a variety of neonatal patient care needs and dilemmas in the field to improve the care of preterm infants and family centered care. The topics included: Oxygen - Getting it Right, Parent Presence Build Brains, Big Data in the NICU, Improving Complex Surgical Care, Closing Keynote: Transformative Futures, Neonatal Abstinence Syndrome, Family Integrated Care, Building Capacity for Improvement, Respiratory Controversies, Emerging Science and Evidence. The agenda also included: The Learning Fair, featuring State and Regional Group Posters, Family Centered Care Posters, and NICU Improvement Story Posters. The meeting was attended by 1162 health professionals and parent representatives from the United States and around the world. | <p>DATABASE/MEMBERSHIP SERVICES Membership. In 2015 there were 984 active members in the Network. Membership in the Network for the Very Low Birth Weight Database (401 to 1500 grams) cost \$4600 in 2015. The 2015 fee for the Expanded Database (all NICU admissions over 401 grams) membership was based on hospital size (AHA Data). Small hospitals were \$5000 per year, medium were \$6200 per year and large or Children's hospitals were \$7400 per year. Membership entitled members to quarterly and yearly reports from the database, access to the Internet reporting system and participation in clinical trials. Scientific studies of the quality of care carried out in intensive care nurseries included preparation of reports on results. In 2016 we published the Vermont Oxford Network Annual Database Summary for 2015, a detailed compendium describing the practices and outcomes at 963 neonatal units caring for very low birth weight infants and the Vermont Oxford Network 2015 Expanded Database Summary describing the practices and outcomes of all NICU infants regardless of birth weight at 415 units participating in the expanded database. The Nightingale Internet reporting system was provided to members. It allows confidential password-protected access to hospital specific reports. | <p>TRIALS Completed Trials awaiting further assessment: Delivery Room Management Trial. Enrollment ceased on March 31, 2009 and data collection continued through June 2009. There were a total of 648 enrollments. Manuscript was accepted at Pediatrics and appeared in November 2011 issue. Analysis continued on 24 month follow-up on these infants in 2014. Help Trial.
