THE CHUNGBA PROJECT --MACHIK CORP (OR MACHIK) FOUNDED THE AWARD WINNING RUTH WALTER CHUNGBA PRIMARY SCHOOL IN THE RURAL COMMUNITY OF CHUNGBA IN EASTERN TIBET. THE SCHOOL PROVIDES FREE EDUCATION AND BOARDING FOR ABOUT 700 RURAL TIBETAN CHILDREN IN BOTH PRIMARY AND MIDDLE SCHOOL. THE CHILDREN'S PARENTS ARE ALMOST ALL ILLITERATE FARMERS AND NOMADS. THESE STUDENTS ARE THE FIRST LITERATE GENERATION IN THE HISTORY OF THIS REMOTE COMMUNITY. SINCE THE SCHOOL FIRST OPENED IN 2002, THESE RURAL CHILDREN HAVE BEEN THE TOP PERFORMERS IN THE REGION IN TIBETAN. GRADUATES OF THE PRIMARY SCHOOL PLACE HIGHLY IN BOTH TIBETAN AND CHINESE LANGUAGE TESTING, THEREBY SHOWING THE VITAL IMPORTANCE OF MOTHER-TONGUE BASED BILINGUAL EDUCATION. MACHIK ALSO CONTINUES TO SUPPORT THE THE MIDDLE SCHOOL GRADUATES TO ATTEND HIGH SCHOOL IN OTHER SURROUNDING COUNTIES. MACHIK ALSO CONTINUES TO SUPPORT THE FIRST AND SECOND GROUPS OF HIGH SCHOOL GRADUATES FROM CHUNGBA TO ATTEND POST-SECONDARY EDUCATION.
