EXPERIENCED NURSE NAVIGATORS PROVIDE FREE ASSISTANCE TO ALL CANCER PATIENTS WHO SEEK HELP FROM THE ORGANIZATION. THE NURSES WORK WITH LOCAL CANCER CARE PROVIDERS TO PROVIDE A SINGLE, CONSISTENT POINT OF CONTACT FOR CLINICAL QUESTIONS AND CONCERNS. NURSE NAVIGATORS EFFECTIVELY ADVOCATE ON BEHALF OF PATIENTS AND THEIR LOVED ONES WHO OFTEN FIND THEMSELVES ADRIFT IN UNCHARTED WATERS. NURSE NAVIGATORS KNOW WHERE TO LOOK AND WHO TO CALL TO GET QUESTIONS ANSWERED. THEY EXPLAIN PATIENTS' DIAGNOSIS AND TREATMENT AND MONITOR THEIR PROGRESS. IN 2015, CANCER NAVIGATORS ASSISTED 480 PATIENTS. THE NURSE NAVIGATOR HAD AN AVERAGE OF 80 PATIENT CONTACTS PER MONTH, IN PERSON OR VIA PHONE. ABOUT 960 HOURS OF NURSE NAVIGATION WERE PROVIDED FOR THE YEAR. NURSE NAVIGATOR SERVICE WAS DISCONTINUED 7/1/2015.

A CANCER DIAGNOSIS HAPPENS ON TOP OF WHATEVER ELSE IS GOING ON IN PEOPLE'S LIVES AND CREATES A DAUNTING ARRAY OF NEEDS BEYOND CLINICAL SERVICES. PATIENTS MAY NEED HELP WITH TRANSPORTATION TO TREATMENTS, AESTHETIC HELP IN THE FORM OF WIGS OR PROSTHESES, HELP WITH INSURANCE OR OTHER RESOURCE PAPERWORK, OR COUNSELING TO HELP WITH THE EMOTIONAL PUNCH CANCER PACKS. A VARIETY OF EDUCATIONAL PROGRAMS AND INFORMATION CENTERED ON PREVENTION AND DEMYSTIFICATION OF TREATMENT ARE ALSO AVAILABLE TO THE PUBLIC, OFTEN IN COLLABORATION WITH OUR COMMUNITY PARTNERS.
