During our year ended December 31, 2015, Prayers From Mana Foundation provided Case Western Reserve Universitys Cancer Center with 125,000 in funding to support the research in the use of nano-technology to more effectively treat pediatric glioma brain tumors. The Organization also provided information and assistance to families with children suffering from gliomas






