The Bureau received and evaluated 3,658 suspected insurance fraud referrals from the insurance industry, members of the public and other sources, of which 1,313 referrals were accepted for further investigation, resulting in 980 new investigative cases. After initial investigation, 573 cases were closed without criminal prosecution due to insufficient evidence of a crime

The Bureau referred 206 cases to federal, state and local prosecutors during the year, and supported those prosecutors in the location of witnesses, witness interviews, delivery of subpoenas and additional investigation. 141 individuals were initially charged with insurance fraud and other crimes during 2015, and court cases involving 218 individuals reached a final disposition.
