Litigation Other Advocacy Represents clients individuals below 200 of the federal poverty level before administrative agencies, the state legislature and state federal courts primarily to ensure that they are able to meet basic needs, including food, housing, utilities, and health care MEJP handled more than 460 cases in 2015, including administrative and legislative matters as well as direct client services These included 146 health care primarily Medicaid related cases, 261 cases concerning food assistance and income support programs, 21 cases concerning employment issues, 10 cases concerning housing and utility matters, and 8 cases concerning consumer issues MEJP also conducted 44 separate training and education events throughout the state on resources and issues affecting people with low income, reaching more than 1,240 service providers and advocates who can better assist their clients - thousands of low-income individuals
