THE ORGANIZATION WAS CREATED IN 1931 TO OWN AND OPERATE A CEMETERY IN JOHNSTON RHODE ISLAND. THE CEMETERY CONSISTS OF OVER 150 ACRES AND CURRENTLY HAS APPROXIMATELY 25,100 BURIALS. THE CARE OF THE CEMETERY IS IN PERPETUITY. DURING THE YEAR ENDED DECEMBER 31, 2015 THE CEMETERY DID APPROXIMATELY 374 BURIALS INCLUDING 347 AT NEED AND 27 PRE NEED. IN ADDITION DURING 2015 THE CEMETERY HAD 60 PRE NEED SALES FOR IN GROUND BURIALS AND 13 PRE NEED SALES FOR ABOVE GROUND BURIALS. SALES FOR AT NEED BURIALS IN 2015 INCLUDED 17 GROUND SITES AND 16 ABOVE GROUND SITES.





