THE NEW CANAAN YMCA IS A MEMBERSHIP ASSOCIATION WITH APPROXIMATELY 9,000 MEMBERS OF ALL AGES, ABILITIES, INCOMES, RACES, AND RELIGIONS. WITH THE ADDITIONAL SERVICES OF AN ESTIMATED 900 INDIVIDUALS VOLUNTEERING NEARLY 15,500 HOURS IN POLICY MAKING, FUNDRAISING, SPECIAL EVENTS, AND PROGRAMS, THE YMCA IS DEDICATED TO PROMOTING COMMUNITY WELLNESS AND DEVELOPMENT, STRONG FAMILIES, YOUTH DEVELOPMENT, AND INTERNATIONAL UNDERSTANDING. 


