SCIENCE PARK DEVELOPMENT CORPORATION ("SPDC") WAS ESTABLISHED IN AUGUST OF 1981 AS A PART OF A COOPERATIVE EFFORT BY THE CITY OF NEW HAVEN, CONNECTICUT, YALE UNIVERSITY, AND OLIN CORPORATION TO MOBILIZE THEIR CONSIDERABLE RESOURCES TO CREATE A NEW ECONOMIC BASE AT THE SITE OF A MULTI-TRACT, PREDOMINATELY VACANT, INDUSTRIAL COMPLEX ADJACENT TO THE YALE SCIENCE HILL CAMPUS AND IN NEW HAVEN'S STATE-DESIGNATED ENTERPRISE ZONE IT'S GOAL IS TO FURTHER THE REVITALIZATION OF THE CITY OF NEW HAVEN THROUGH THE DEVELOPMENT AND ENHANCEMENT OF EMPLOYMENT OPPORTUNITIES FOR AREA RESIDENTS, RELIEF OF POVERTY AND NEIGHBORHOOD TENSION, AND THE PREVENTION OF BLIGHT AND DETERIORATION IN THE SURROUNDING DIXWELL-NEWHALLVILLE NEIGHBORHOOD AREAS THE PARK ATTRACTS START-UP BIOTECH AND TECHNOLOGY FIRMS, INCLUDING LIFE SCIENCE, HIGH TECHNOLOGY, WEB APP DEVELOPMENT, FINANCIAL TECHNOLOGY, AND LIGHT MANUFACTURING AND ASSEMBLY INDUSTRIES AS A HOME BASE FOR THESE COMPANIES, SPDC PROVIDES ECONOMIC BENEFITS TO THE CITY OF NEW HAVEN AS A WHOLE, AND OFFERS INDIRECT EMPLOYMENT OPPORTUNITIES TO AREA RESIDENTS IN ADDITION, SPDC HAS MADE OFFICE SPACE AVAILABLE TO SEVERAL SOCIAL SERVICE AND EDUCATIONAL ORGANIZATIONS, WHICH DIRECTLY SERVE THE FAMILIES IN THE NEIGHBORHOOD AND THROUGHOUT NEW HAVEN SCIENCE PARK TALLIES OVER 33 COMPANIES AND NOT-FOR-PROFIT ORGANIZATIONS WITH OVER 1300 PEOPLE IN THE SCIENCE PARK PLANNED DEVELOPMENT DISTRICT TENANT COMPANIES AT SCIENCE PARK ARE PART OF A DYNAMIC R&D COMMUNITY AND CAMPUS-LIKE ENVIRONMENT THESE COMPANIES BENEFIT BY ASSOCIATION AND USE OF FACILITIES WITH NEARBY YALE UNIVERSITY IN JULY OF 1998, THE CONNECTICUT HOUSING FINANCE AUTHORITY ("CHFA") COMMITTED \$14 MILLION TO DEMOLISH OBSOLETE STRUCTURES, AND TO REHABILITATE AND/OR CONSTRUCT NEW BUILDINGS IN THE PARK YALE UNIVERSITY PROVIDED SUPPORTING FUNDS DURING CONSTRUCTION ACTIVITIES, OLIN CORPORATION APPROVED DONATION OF ADDITIONAL LAND AND FACILITIES, AND THE CITY OF NEW HAVEN PROVIDED CONTRIBUTIONS IN THE FORM OF CAPITAL IMPROVEMENTS THESE WERE IN ADDITION TO PREVIOUS COMMITMENTS TO THE PARK FROM THE CONNECTICUT DEVELOPMENT AUTHORITY ("CDA", NOW CONNECTICUT INNOVATIONS INC "CII") AND DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT ("DECD") THE MAJOR PORTION OF THE CHFA FUNDS WERE USED TO RENOVATE AND EXPAND A 102,000 SQUARE FOOT OFFICE/LAB BUILDING THAT IS NOW LEASED AND OCCUPIED, PRIMARILY TO COMPANIES IN THE BIOTECH FIELD GROUND LEASE TRANSACTIONS IN 2000 AND SUBSEQUENTLY, BETWEEN SPDC AND A FORMER DEVELOPER RESULTED IN THE INFILL AND RENOVATION OF A 267,000 SQ FT OFFICE/LAB BUILDING, RENOVATION OF PARKING LOTS ENCOMPASSING APPROXIMATELY 250 PARKING SPACES, AND DEMOLITION OF FIVE ABANDONED AND DERELICT BUILDINGS BEGINNING IN 2007, A NEW DEVELOPER ASSUMED THREE GROUND LEASES UNDER THESE AND SUBSEQUENT LEASES, ADDITIONAL ABANDONED AND NON-SALVAGEABLE BUILDINGS WERE DEMOLISHED, A STRUCTURED PARKING GARAGE FOR OVER ONE THOUSAND VEHICLES WAS COMPLETED, A VACANT FACTORY WAS RENOVATED FOR OFFICE AND TECHNOLOGY TENANTS, AND A CHILLED WATER FACILITY SHELL WAS COMPLETED IN 2011 IN 2007, SPDC ISSUED AN RFQ FOR DEVELOPMENT OF A SEVEN ACRE ABANDONED, DERELICT, MULTI-BUILDING TRACT IN SCIENCE PARK IN 2011, A NASDAQ-TRADED FINANCIAL TECHNOLOGY COMPANY ENTERED A COMMERCIAL GROUND LEASE FOR PART OF THIS TRACT AND BUILT AND/OR RENOVATED THREE BUILDINGS PERIPHERAL AGREEMENTS ENCOMPASSED TWO ADDITIONAL SPDC TRACTS IN 2013, A RESIDENTIAL GROUND LEASE WITH A NATIONAL DEVELOPER WAS EXECUTED RESIDENTIAL HOUSING, INCLUDING 158 LOFT-STYLE RENTAL UNITS IN SIX HISTORIC, RENOVATED BUILDINGS ON THE SEVEN-ACRE TRACT, WAS COMPLETED IN JANUARY 2015 AND WAS ALMOST FULLY OCCUPIED BY THE END OF 2015 THIS HOUSING INCLUDES 20% AFFORDABLE HOUSING UNITS UNDER THE CONNECTICUT DEPARTMENT OF HOUSING IN ADDITION, TWO BUILDINGS WERE DEMOLISHED TO CREATE SHARED PARKING ON ANOTHER TRACT ENVIRONMENTAL BROWNFIELD REMEDIATION GRANTS WERE AWARDED BY THE DECD IN 2014 TO BEGIN ENVIRONMENTAL ASSESSMENT AND REMEDIATION WORK ON THE SECOND RESIDENTIAL PHASE ON THE TRACT ASSESSMENT WORK WAS COMPLETED IN 2015 AND DEMOLITION AND REMEDIATION WILL BEGIN IN 2016, WITH THE HOPES TO DEVELOP THE REMAINING PORTIONS OF THE PARK BY 2020, TO ATTRACT BOTH RESIDENTIAL AND COMMERCIAL TENANTS IN 2014, TWO OF THE GROUND LEASES WERE SOLD TO THE OWNERS OF THE BUILDINGS THEREON SIMULTANEOUSLY, THE CII AND CHFA LOANS WERE REFINANCED AS A RESULT OF THE REFINANCING, REPAYMENT TERMS WERE CHANGED AND THE REMAINING PROCEEDS WERE SET ASIDE FOR WORKING CAPITAL AND FUTURE INVESTMENT AND REMEDIATION OF THE REMAINING SPDC-OWNED PROPERTIES AS WELL AS MUCH-NEEDED REPAIRS TO EXISTING OFFICE AND LAB SPACE BUILDINGS CLOSE TO \$500,000 IN REPAIRS WERE COMPLETED IN 2015 AND OVER \$1.5 MILLION WAS INVESTED IN THE ENVIRONMENTAL ASSESSMENT AND DEVELOPMENT DESIGN FOR THE UNDEVELOPED REMAINS OF SCIENCE PARK USING THESE PROCEEDS AND DECD GRANT MONIES, NOT INCLUDING ADDITIONAL FUNDS SPENT BY SPDC'S DEVELOPMENT PARTNER SCIENCE PARK IS, AND WILL CONTINUE TO BE, A VIBRANT, INTEGRAL PART OF SURROUNDING NEIGHBORHOODS, NEW HAVEN, AND CONNECTICUT AS A WHOLE
