Research Capacity Strengthening (RCS)

1. The program supported 23 new doctoral students drawn from several universities in Africa in addition to giving 3 re-entry grants to graduated students under the African Doctoral Dissertation Research Fellowships (ADDRF). This brought the total number supported by the program to 195 students since its commencement in 2008. 109 have successfully completed their studies & most of the graduates have been retained in their institutions in Africa.

2. The Consortium for Advanced Research Training in Africa (CARTA), an initiative involving 9 African universities, 4 African research institutes & selected northern partners has had 150 doctoral students undergo training, 25 joining in 2015. The program, was able to:

- continue with a model collaborative doctoral training program with strong supervision and mentoring components.
- strengthen infrastructure, skills & faculty commitment to lead & manage research initiatives within the institutions
- contribute to the improvement of environments at African universities with the aim of facilitating and motivating researchers to stay and contribute to scholarly work within the region. 24 have successfully completed their studies and most of the graduates retained in their institutions in Africa.

The Health Challenges and Systems (HCS) Research Program - This program is at the forefront of regional research to understand & health challenges that affect most people in sub-Saharan Africa. Major activities and achievement for 2015 include:

- Contributed to the finalization of the Kenya Baby Friendly Community Initiative Implementation guidelines
- Contributed to the Global Nutrition Report 2015: actions and accountability to advance nutrition & sustainable development.
- Offered technical assistance up to 8 countries in Sub-Saharan Africa for the Accountability for Health Framework since it began.
- Has helped update the Global Health Expenditures data and in the analysis of NCD prevention policies in Africa (ANPPA) - this which involved conducting case studies in six African countries.
- Contributed to the Kenya STEPs 2015 survey and report, the first nationally representative survey to collect comprehensive information on risk factors for NCDs, injuries and oral health in adults' age 18 - 69 years.

Population Dynamics Program

1. We conducted a systematic review on effective interventions to improve quality of maternity care in the sub Saharan Africa and a qualitative research in Nigeria on perceptions regarding quality of maternity care in Nigeria

2. Continued with "Meeting the Unmet Need for Family Planning & Improving Access to Safe Abortion Services (STEP UP)" project which seeks to improve access to family planning & safe abortions in Kenya, Ghana, Senegal, Bangladesh & India.

3. Continued with evaluation of a set of interventions on improving the delivery and uptake of family planning in Western Kenya with the aim of reversing the stall of fertility decline in this particular region.

Impact: A noticeable expansion of community health workers' activities and a strong involvement of the Ministry of Public Health and Sanitation at the national, provincial and district levels. Study got the government to invest into family planning in two counties.

4.
