Healing Program - LWB's Medical Program helped 215 children in 2015, with 179 of them receiving surgery The majority of these operations were completed at the Childrens Hospital of Fudan University in Shanghai and Anhui Childrens Hospital in Hefei LWB held another successful cleft exchange in April, with physicians from Minnesota and California working side by side with doctors at Kaifeng Childrens Hospital to provide surgenes for both orphaned and rural children Of the life-changing surgenes we provided, 57 were for children born with congenital heart defects In 2015, LWBs medical program helped children from 13 provinces and 38 different orphanages

Education Program - We strongly believe that all children deserve the opportunity to receive an education However, many orphaned children born with medical needs are unable to attend public schools It is for these children that we created our in-orphanage "Believe in Me" school program In 2015, we operated six Believe in Me schools in Changzhi, Huainan, Jinjiang, Lanzhou, Qingyang, and Shaoguan Our newest school was opened in Qingyang, Gansu in February 2015 The students in these schools get to experience the wonder of music, art, and reading, as well as participating in educational and fun field trips outside the walls of their institutions Each school offers a daily snack program for improved nutrition and a daily dental program to improve the children's oral hygiene Over 200 children were enrolled in our Believe in Me orphanage schools in 2015 Over 50 additional children in LWB foster care received preschool and kindergarten services in 2015 as well

Foster Care Program - To be nurtured, cared for, and loved is the right of every child We firmly believe that children need families for their best physical and emotional development, and so whenever possible we work to place children into loving foster homes LWB ran foster care programs in 16 cities in China during 2015, providing foster care to 259 children Highlights include the permanent adoption of 87 of these children, an increase of seven from 2014, and welcoming 85 new children into our program All children in LWB foster care are visited monthly in each city by our local managers who fill out height and weight sheets, take photos, and interview both the families and children To improve nutrition for our youngest children in foster care, we provided food blenders and a First Foods for Babies handout developed by our nutrition program Fortified cereal continues to be provided for babies up to the age of 18 months In addition, iron supplements and other vitamin and mineral supplements were provided to children who needed them

However, as orphanage resources improved in many provinces, we continued to switch our emphasis in 2015 to ensuring that the children in our schools, foster care, and healing homes receive the best nutrition possible for their physical development. Daily supplemental snacks such as eggs, fruit, and almonds are given to the students in our Believe in Me schools to ensure that no child goes hungry during the school day. In foster care, we provide fortified infant cereal to babies up to 18 months of age, as well as multi-vitamins and specialized formula to children needing extra assistance. LWB's Nutrition Program continued to provide infant formula to the babies in each of our healing homes, as well as to infants in the Huainan orphanage in Anhui. We also provided specialized preemie and synthetic formulas to children when needed. Specialized formula in China is very expensive, making it well beyond the budget of many orphanages at \$350 to \$750 for a one-month supply for a single child. We were grateful in 2015 to be able to provide this life-saving formula to many children in orphanage care when we learned they had become failure-to-thrive.
