As Western Pennsylvania's first and only continuing care at-home membership program, Longwood at Home was developed, and continues to be operated by Presbyterian SeniorCare Established on January 25, 1928 in the Commonwealth of Pennsylvania, Presbyterian SeniorCare is a not-for-profit, charitable organization which provides facilities, services and programs for enhancing the quality of life of older adults
