THROUGH THESE EDUCATIONAL ACTIVITIES SUCH AS WORKSHOPS, CLINICS AND DEMONSTRATIONS, YOUNG PEOPLE ARE INTRODUCED TO CORRECT PRACTICES EMPHASIZING IMPROVED PRODUCTION OF LIVESTOCK, AGRICULTURAL AND HORTICULTURAL PRODUCTS.
