ENERGY SECURITY PROGRAM OVER THE PAST YEAR, PSSI AND ITS PARTNER ORGANIZATION, THE ENERGY FACULTY AT MASARYK UNIVERSITY, HAVE BEEN RESEARCHING AND CLOSELY MONITORING THE RAPIDLY CHANGING ENERGY SECURITY ENVIRONMENT IN CENTRAL AND EASTERN EUROPE, PARTICULARLY SINCE THE DEEPENING OF THE UKRAINE CRISIS IN MARCH 2014 RUSSIA HAS CONTINUED TO MOVE AGGRESSIVELY TO CONSOLIDATE ITS COMMANDING ENERGY POSITIONS IN A NUMBER OF COUNTRIES IN THE REGION (AS WELL AS THE BALTIC STATES), ESPECIALLY IN THE NUCLEAR ENERGY SECTOR MOSCOW HAS ALSO, IN EFFECT, "WEAPONIZED" ITS MAJOR ENERGY-RELATED STATE-OWNED ENTERPRISES, NOTABLY ROSATOM AND GAZPROM MOST OF THE REGIONAL EU AND/OR NATO MEMBER STATES HAVE RECOGNIZED THEIR PERILOUS LEVEL OF ENERGY DEPENDENCY ON RUSSIA AND ARE TAKING STEPS TO MITIGATE THE GROWING RISKS ASSOCIATED WITH SUCH DEPENDENCY IN THIS CONNECTION, THE EU'S THIRD ENERGY PACKAGE HAS BEEN A HIGHLY USEFUL TOOL IN PROVIDING CENTRAL AND EASTERN EUROPEAN CAPITALS WITH POLITICAL COVER AND DIVERSIFICATION REQUIREMENTS TO SEEK TO EXTRICATE THEMSELVES FROM THE POLITICAL AND STRATEGIC LEVERAGE BEING EXERCISED BY THE KREMLIN THROUGH ITS STATE-OWNED ENERGY ENTERPRISES THAT SAID, SOME COUNTRIES SUCH AS HUNGARY AND BULGARIA HAVE SHOWN THEMSELVES AMENABLE TO ACTUALLY BOLSTERING THEIR DEPENDENCY ON RUSSIAN ENERGY SUPPLY RELATIONSHIPS, DESPITE THE ANNEXATION OF CRIMEA AND CONTINUED MOSCOW-SPONSORED TURMOIL AND CONFLICT IN EASTERN UKRAINE TO ENRICH PSSI'S UNDERSTANDING OF THIS REGIONAL ENERGY SECURITY DYNAMIC, IT CONVENEED A LARGE CONFERENCE IN JUNE 2015 WITH OVER 100 PARTICIPANTS FROM A DOZEN COUNTRIES IN THE MEETING HALL OF THE CZECH SENATE THIS DAY AND A HALF EVENT ATTRACTED SIGNIFICANT ATTENTION AT EUROPEAN POLITICAL LEVELS A REPORT THAT WAS TWO YEARS IN THE MAKING EXCEEDED 700 PAGES AND RECEIVED WIDE DISTRIBUTION TO THE GLOBAL ENERGY COMMUNITY IT CONSTITUTED AN ENORMOUS JOINT EFFORT BY MASARYK UNIVERSITY (MUNI) AND PSSI AND INVOLVED NUMEROUS INTERVIEWS WITH COUNTRY EXPERTS THROUGHOUT THE REGION
