The Foundation is working with other New York organizations and serving as one of seven organizations across the country to achieve this goal, in collaboration with 29 New York nursing facilities. The CMS NF program represents approximately 80% and 79% of total grant and contributions revenue in 2015 and 2014, respectively, and approximately 61% and 60% of total grants receivable as of December 31, 2015 and 2014, respectively
