Azerbaijan SEDA-Program 3018In Azerbaijan, EWMI implements the Socio-Economic Development Activity (SEDA), a project funded by the United States Agency for International Development (USAID) and co-financed by the Government of Azerbaijan (GoA) SEDA contributes to the advancement of socio-economic development at the regional level in Azerbaijan by providing support for community-driven socio-economic projects (CSEPs) and strengthening stakeholder participation in setting priorities for socio-economic strategies and programs in three regions of Azerbaijan SEDA works under three components Component One - Supporting Community Socio-economic Projects, Component Two - Strengthening Civil Society Organizations, and Component Three Working with Government of Azerbaijan During SEDA's Year 5 (October 2014 - September 2015), EWMI selected 14 new communities that will benefit from SEDA support during the no cost extension (October 2016 - December 2017) granted by USAID, conducted and assisted 628 community mobilization activities in the 110 communities that SEDA supports, and completed 23 CSEPs 4,783 people (3,062 men and 1,721 women, of which 533 were youth, 70 were IDPs, and 686 represented local authorities participated in the election and re-elections of SEDA-supported Community Development Committees (CDCs) In May 2016, EWMI also held the second Annual National Community Development Conference with 157 participants In Component Two, EWMI trained 153 representatives of civil society organizations (CSOs) and 438 representatives of local government institutions on Application of Legal Changes in Reporting by CSOs, Using E-services for CSOs, and Establishing Public Councils EWMI also supported the work of two Regional NGO Resource and Training Centers In Component Three, EWMI conducted a comprehensive survey on "The Legal Framework for NGO Activities in Azerbaijan" with the participation of 102 CSOs in Azerbaijan and organized the 2nd Annual Advanced Seminar for Participatory Policy Development with the participation of 21 representatives of government institutions and CSOs from the regions

Kyrgyzstan CGP-Program 3021The Collaborative Governance Program (CGP), funded by the United States Agency for International Development (USAID), is a five-year project that works to foster effective collaboration between civil society, the private sector, and the Government of the Kyrgyz Republic (GoKR), resulting in a more responsible and accountable government, improved delivery of social services to citizens, and a more credible and sustainable civil society CGP supports the GoKR's efforts to increase civil society participation in service delivery through social procurement mechanisms and works to strengthen civil society's ability to shape public policy, enhance government transparency and outreach to citizens, as well as expand civic engagement and advocacy efforts To improve the capacity of local civil society organizations (CSOs), CGP has developed a process that includes an initial voluntary profiling of CSOs, followed by a diagnostic review of interested CSOs that reveals their individual strengths and weaknesses CSOs that complete this process receive organizational health reports and capacity strengthening plans By the end of FY15, 418 organizations had completed the profiling process and 175 had undergone the diagnostic process CGP offered a series of organization development seminars to CSOs that completed the diagnostic process CGP has also introduced non-profit management (NPM) education to 11 Kyrgyz universities, in an effort to develop and build the skills of the next generation of civil society leaders By the end of 2015, CGP had introduced three new NPM courses that were delivered to over 880 students at the participating universities
