During the program there are workshops with a critic-in-residence, visits by gallerists, critics, curators and other artists. Evenings offer lectures, slide presentations and panel discussions. At the end of the program, there is an Open Day where the general public is invited to visit. Through the residency program, awards are presented every two years to under-recognized artists of outstanding merit.
