The Foundation is dedicated to advancing the health of all dogs and their owners by funding sound scientific research and supporting the dissemination of health information to prevent, treat, and cure canine disease Within the mission, the AKC Canine Health Foundation has three primary goals - To fund canine health research projects to the Foundation's capacity which address the diversity of canine health concerns and may have comparative medicine benefits for humans - To select and monitor, through a rigorous process, research projects that meet high scientific standards and have the greatest potential for advancing the health of dogs - To communicate to pet-owners, veterinarians and researchers funded discoveries that help prevent, treat and cure canine diseases TO COMMUNICATE TO PET-OWNERS, VETERINARIANS AND RESEARCHERS FUNDED DISCOVERIES THAT HELP PREVENT, TREAT AND CURE CANINE DISEASES

Biomedical research is measured by the contribution of a given project or group of like projects to the greater understanding of the disease(s) under study One tangible measurement of this contribution is through peer-reviewed publication of results from AKC Canine Health Foundation-funded research Such publications are accessible to all researchers in the field and the public Each publication becomes a stepping stone on a path to solving problems and meeting the unmet medical needs for canine health In 2015, the AKC Canine Health Foundation saw our funded research, across program areas and especially in canine cancer and comparative oncology, published in such high impact scientific journals as Chromosome Research, BMC Cancer and BMC Genomics, Molecular Cancer Research, International Journal of Oncology, Journal of Veterinary Internal Medicine, PLoS Genetics, and Tissue Engineering and Regenerative Medicine Additionally, AKC Canine Health Foundation-funded researchers published review articles in peer-reviewed journals that have a broad reach to the public, veterinarians and scientists, and enhance understanding on the state of any given disease condition Publication topics included canine cancer (hemangiosarcoma, lymphoma, bladder tumors, squamous cell carcinoma), kidney disease, genetics, thyroid disease, platelet function and epilepsy

The AKC Canine Health Foundation endeavors to provide funding and education to invest in and train the next generation of researchers for canine health One way we achieve this is through the AKC Canine Health Foundation Clinician-Scientist Fellowship program Three of these fellowships were awarded in 2015 to advance training in canine cancer research at the University of Missouri, Cornell University and Colorado State University

As part of its mission, the AKC Canine Health Foundation aims to educate all dog owners and communicate research discoveries that help prevent, treat, and cure canine diseases In 2015, as part of this educational component of our programs, CHF hosted a bi-annual national conference for two full days on canine health in St Louis, Missouri The conference brought in 20 experts from around the world to speak about the latest findings in canine health research to 270 attendees, including many breeders, veterinarians and veterinary students One major donor concern is cancer, a disease that can be devastating to both dogs and people In addition to the 7 new grants funded in 2015 to fight canine cancers including lymphoma, hemangiosarcoma and osteosarcoma, funding for improved cancer diagnostics will help dog owners and their veterinarians better diagnose and treat their dogs News about this work in canine cancer and its relevance to human cancer made headlines in articles in WebMD and Fierce Animal Health, further disseminating this work and reaching a wide public audience CHF also released 7 new podcasts and held 4 live webinars for the dog owner and veterinarian, covering everything from senior dog care to new advances in cancer research Additionally, employees attended many dog shows, events and educational conferences to promote and increase awareness of 1) the Foundation and our mission and 2) the wealth of information and resources we have made available to the public
