Education. Each month, the Mississippi Center for Justice's (Center) education team handled cases for 10-15 students facing long term suspension or expulsion, or seeking IDEA compliance, at no cost to the parents. In handling these cases, the Center identified opportunities to correct systemic problems, such as the need for uniform statewide due process standards and procedures, including the adoption of a standard of proof in due process hearings. In preparation for an all-out push to get uniform due process standards and procedures adopted statewide, the Center produced a white paper about the disproportionate discipline rates for students of color, "Overrepresented and Underserved." On advocacy for adequate school funding, the Center provided support for a proposed constitutional amendment requiring adequate school funding which failed to get the required 60% of the vote for passage.

Consumer Protection. The Center's foreclosure prevention initiative, funded by the National Foreclosure Settlement, opened 181 new cases defending foreclosures or arranging workout agreements where possible. All representation is free to the client. The Center was chosen to house a financial coach for three years through a program with the United States Armed Services and the Consumer Finance Protection Board, who will be able to counsel the Center's clients in budgeting and other financial matters. The Center expanded the New Roots Credit Partnership, its employer-based alternative to payday lending, by adding Sanderson Farms one of the state's largest employers as a participant bringing the total eligible employee base to 8,300. Through a grant from the Women's Foundation of Mississippi, the Center offered workshops and individual representation to community college students on student loans, expungement and fair housing issues.

Healthcare Access. Through a grant from Atlantic Philanthropies, the Center did extensive outreach on the Affordable Care Act, assisting in the initial enrollment period under the state exchange. The Center worked with students at Tougaloo College, initiating a #Students4Coverage Instagram campaign and mobilized clergy in Jackson and the Delta to provide information through the pulpit. Through a grant from the Elton John Foundation, the Center represented 20 clients with HIV/AIDS in discrimination matters through its medical legal partnership, and health lawyers met with the owner of statewide convenience stores to educate him on what he can and cannot do with employees living with HIV. AIDS advocacy work was done with support from AIDS United/Southern REACH.
