If the Association's staff members identify a conflict of interest, management shares this information with the Executive Committee of the board for its action. Involved board members are precluded from voting on matters for which a conflict exists.

The process includes the completion by the supervisor of a performance appraisal instrument, a self-appraisal, and comments gathered from employees. Top management positions are evaluated by the Executive Committee of the Board of Directors, led by the current year President. An evaluation form is completed, a self-appraisal, the capacity building model developed by McKinsey & Company is completed, and comments gathered from all board members and key staff. Compensation is determined using comparability data from the Washington, DC metro area, the ASAE compensation study of similar positions, and any other available compensation reports that are current.
