A \$1,000 CASH AWARD IS GIVEN YEARLY TO THE WINNER IN EACH CATEGORY OF SOCIAL SCIENCES AND HUMANITIES. THE HOURANI BOOK AWARD HONORS ALBERT HOURANI FOR HIS LONG AND DISTINGUISHED CAREER AS TEACHER AND MENTOR. THE AWARD WAS ESTABLISHED IN 1991 TO RECOGNIZE OUTSTANDING PUBLISHING IN MIDDLE EAST STUDIES. EACH YEAR THE WINNER OF THIS AWARD RECEIVES \$1,000 (IN THE CASE OF SHARED AWARD, EACH RECIPIENT RECEIVES \$500). THE MENTORING AWARD WAS ESTABLISHED IN 1995 TO RECOGNIZE EXCEPTIONAL CONTRIBUTIONS THAT RETIRED FACULTY HAVE MADE TO THE EDUCATION AND TRAINING OF OTHERS. EACH YEAR THE MESA BOARD OF DIRECTORS SELECTS THE WINNER WHO RECEIVES AN AWARD CERTIFICATE.
