We are a 410 bed facility with more than 225 certified physicians in over 25 specialties. Our services include, but are not limited to, emergency care, surgical services, mental health, cancer care, primary care and preventative health education. In 2015, we had 71,726 patient days and 14,391 discharges. The Emergency Care Center provided care to 51,698 patients. Our Mental Health department provided 76,837 outpatient treatments and 7,313 inpatient days. Our Surgery Center performed 12,423 procedures.
