Problem Gambling Prevention and Treatment Opportunity Program Partnering Association signed a contract agreeing to participate in the project until 12/31/15 and to complete services in accordance with NYCPG guidelines. Partnering Association was required to submit a program activity form by 12/15/15 and an expense report with accompanying receipts by 12/31/15. Any funds not spent by 12/31/15 were required to be returned to NYCPG.
