A copy is also given to the Macedon Library Board of Trustees as well as the Macedon Town Clerk available to the public for review. She posts a notice on our local newspaper, "The Times of Wayne County" which includes the Macedon Public Library, the Macedon Consolidated Health District and the Town of Macedon A.U.D.

Monthly balance sheets, bank statements and a consolidated revenue & expense statements are provided each month to our monthly library Board of Trustees needed. We have many balances and checks to be sure that our accounts, director, treasurer & board members are aware of how everything is tied together & taught how to be sure everything is balanced appropriately.

On or before May 15th, following the end of the nys fiscal calendar year (12/31/2015), the Treasurer prepares and submits the Form 990 along with Schedules A & C to the Department of the Treasury as we are a 501(c)(3) corporation as required by law. The library Director & each member of the library Board of Trustees receives one as well for their review & files.
