LEAP speakers gave 871 presentations in the United States and internationally. These were to high schools, colleges, civic groups, service organizations, churches, city councils and radio and television interviews. All were on prohibition, the role of policing, and drug policy. We were instrumental in the 600 New England churches resolution calling for an end to prohibition. LEAP Brazil met the former president of Uruguay, the LEAP UK chapter met with officials at 10 Downing Street, and we helped MPP pass a resolution at the NCSL conference to allow states to decide their own marijuana laws.

LEAP representatives attended conferences domestically and abroad. We reached people involved in drug policy, the media, universities, law enforcement, politics, government and the law. LEAP sets up a booth with videos on prohibition and drug policy, talks to attendees and distributes flyers and other information. At some we are featured speakers.

Outreach: LEAP was in the media 505 times, including 268 radio shows, 60 television appearances, 1,404 mentions in written publications and 86 published original pieces written by LEAP speakers. We have a large, active Facebook, LinkedIn, Twitter and YouTube following. We continue outreach to possible endorsers like medical associations, civil rights organization, police associations, prison rights groups, etc. We also distribute brochures, DVD's, t-shirts.
