All companies participating in the UN Global Compact are strongly encouraged to make an annual voluntary contribution to the Foundation. All funds raised by the Foundation go directly toward building and improving tools, resources and activities that mainstream the Global Compact's Ten Principles in business strategy and operations around the world. Each year, a portion of the Foundation's funds are transferred to the UN Global Compact's Trust Fund to help the Global Compact cover its operating costs. In 2015, the Foundation transferred \$2.3 million to the Global Compact Trust Fund. Additionally, in 2015 the Foundation raised grant, event sponsorship and direct support funding for programs including the Global Compact Africa Strategy, Business for Peace, Business for the Rule of Law, Caring for Climate, CEO Water Mandate, Private Sustainability Finance, Human Rights and Business Dilemmas Forum, Anti-Corruption, Women's Empowerment Principles, Food and Agriculture Business Principles, Reporting, and UN-Business Partnerships.
