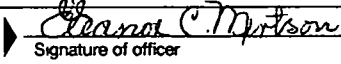

ment for the use of patrons of all ages. Of the \$46,000 given, \$10,000 was for the purchase of books and related materials to supplement

the Library's collections. \$24,700 was given for programs and activities for Children, Teens and Adults. The largest portion of funds for

Children's programs was allocated to the summer reading program. With the 2015 theme, "Every Hero Has a Story," 369 children, 57 young

adults, and 130 adults read 5,902 books in just six weeks. The Children's Department also hosted 186 programs for children with 5963 at-

tendees and 40 programs for young adults with 578 attendees. Among Teen programs and activities were the Torn Page Writers group;

Teen Tech Fridays; Game, Anime and Cooking Clubs as well as arts and crafts projects. The Friends' gift provided money for two outdoor

movie licenses where the Library partnered with the Corning Parks and Recreation Department to host two Float n' Flick events at city pools

with 225 attendees. The Children's Department was also able to host a family concert by the Doc Possum Band - a salute to The Beatles, a

pop art family craft program and purchase reading incentives for a Treasure Chest, a weekly prize basket and craft supplies.

Adult programs for 2015 included creative writing workshops on essays, memoirs, poetry and novels; a dozen programs that brought writers together for writing time as a group or discussion about writing, some with guest speakers or performers, including a poet, author and filmmaker; craft projects; a concert of music and stories inspired by the West and 20 evenings of free Friday films. Other participants enjoyed practicing their English-language speaking skills at "Coffee Tea and English," a program bringing people together for whom English is not their native language. Funds were also used for bringing books to shut-ins, a summer promotional giveaway, and weekly summer reading prize baskets. The \$1,500 allocated to the BE-Lab project was for expenses in connection with the Library's access to broadband. The Friends provided \$3,800 for a Volunteer Recognition dinner to enable the Library to thank its more than 100 volunteers who have given their time to innumerable tasks over the course of the year. A supplemental amount of \$6,000 was given to the Director to be used wherever she believed the funds would have the greatest impact on the community the Library serves.

Part III, Line 29 - Southeast Steuben Library Endowment Fund gift: The Friends gave \$3,000 to the Endowment Fund established by the Library Trustees for the purpose of providing a portion of support, as necessary, for the ongoing operations of the Library.

Part III, Line 30 - Books Sandwiched In and Books for Babies Programs sponsored by the Friends: Each year, the very popular Books Sandwiched In series of six programs presented during January and February draws an average of 70 - 75 attendees per week to the Library. Reviews of current, popular or noteworthy books are given by well-known people in the community. There are no charges for persons attending these programs. Costs of the series are for advertising, refreshments and for Barnes & Noble gift cards given to the reviewers - \$239. Another program service that carries out the purposes of our organization is the Book for Babies Program. This literacy program acquaints parents of newborns with the important role they play in the development of their children. Each new mother receives a child's board book together with a packet of information about the Library's collections, programs and services for babies and children and the value of parents reading to their little ones. Approximately 300 books were purchased and given away in 2015 at a cost of \$398.

The Friends give all grants to the Library in December of each year so that Library staff may begin early planning for the coming year's programs and activities.
