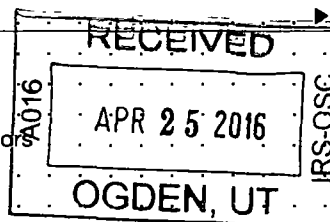

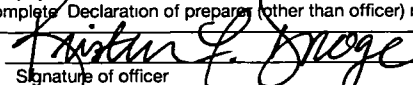

The balance is primarily made up of the following: \$24,237 for race management to plan/coordinate our race day; \$15,974 for race day timing services; \$15,425 in USAT sanctioning fees paid to USA Triathlon (includes 1-day insurance for all racers on the day of the event); \$12,777 for traffic control along the course; \$14,659 for racer finisher tee-shirts; \$10,909 for new safety signs and ambiance along the bike/run course; \$5,708 for facility rentals; \$5,447 for bank/credit card fees; \$1,855 for racer bibs; \$1,980 for racer swim caps; \$2,400 for collective racer charms; \$2,435 for racer water bottles; \$3,574 for equipment rentals; \$4,360 for website management; \$1,815 for awards; \$1,143 for permits; \$2,500 for racer bags.
