WE RESPOND BY INTEGRATING EDUCATIONAL OUTREACH, SMART PROGRAMMING, EFFECTIVE POLICIES, AND THE HANDS-ON WORK OF THOUSANDS OF VOLUNTEERS. WE PROVIDE FOOD, SHELTER, AND SUPPORT SERVICES FOR HOMELESS FAMILIES. WE EDUCATE PEOPLE ABOUT POVERTY AND THE MEANS TO COMBAT IT. FAMILY PROMISE OF YELLOWSTONE VALLEY (FPYV) PARTNERS WITH 26 LOCAL CONGREGATIONS TO PROVIDE FOOD, SHELTER, TRANSPORTATION AND A SAFE ENVIRONMENT FOR SELECTED FAMILIES EXPERIENCING HOMELESSNESS. MEMBER CHURCHES TAKE TURNS HOSTING FAMILIES ONE WEEK AT A TIME. DURING THE DAY, FAMILIES WHO ARE NOT WORKING OR IN SCHOOL ARE BASED AT FPYV'S DAY CENTER, WHICH IS HOUSED IN DONATED SPACE IN A MEMBER CHURCH. FPYV ALSO HAS TWO DUPLEXES, WHICH PROVIDE TRANSITIONAL HOUSING FOR THOSE GUESTS WHO ARE FINANCIALLY AND EMOTIONALLY READY TO SUCCESSFULLY BEGIN LIVING ON THEIR OWN WITHIN THE SAFETY NET OF FPYV. UNIQUELY, FPYV PROVIDES CASE MANAGEMENT FOR PARENTS TO ASSIST THEM TO FIND EMPLOYMENT, CHILDCARE, NEEDED HEALTHCARE, AND OTHER ASSISTANCE NECESSARY TO REGAIN AND SUSTAIN THEIR INDEPENDENCE. EDUCATIONAL PROGRAMS ARE ALSO PROVIDED TO IMPROVE PARENTING AND PERSONAL FINANCIAL SKILLS. EDUCATIONAL SESSIONS ARE HELD PERIODICALLY FOR FAMILIES IN THE NETWORK, INCLUDING THOSE IN TRANSITIONAL HOUSING. ONGOING CASE MANAGEMENT AND EDUCATION IS ALSO OFFERED TO THOSE WHO HAVE MOVED INTO THEIR OWN HOUSING. PARENTING AND PERSONAL FINANCE CLASSES ARE HELD ON A ROTATING BASIS, AND ATTENDANCE IS REQUIRED FOR ADULT GUESTS, AS THEY ARE PUT ON A TRANSITIONAL PLAN FOR SELF-SUFFICIENCY. EDUCATION IS A TOP PRIORITY AT FPYV. AFTER SCHOOL AND SUMMER ACTIVITIES ARE PROVIDED ALSO TO ENHANCE THE LEARNING ENVIRONMENT FOR THE CHILDREN. IN 2015, OVER 86 HOMELESS FAMILIES WERE SERVED THROUGH THE NETWORK. APPROXIMATELY 70% OF THE INDIVIDUALS SERVED IN 2015 WERE CHILDREN (INFANT - 17 YEARS). 85% OF ADULTS BECAME EMPLOYED FULL-TIME WITHIN 28 DAYS OF ENTERING THE FPYV PROGRAM. WE PROVIDED 3,820 NIGHTS OF EMERGENCY SHELTER TO HOMELESS FAMILIES AND WORKED CLOSELY WITH THE BILLING SCHOOL DISTRICT TO KEEP THEIR CHILDREN IN SCHOOL.
